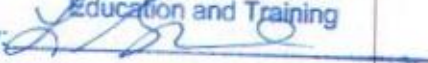

FINAL ORDER OF REVOCATION

by: 

The Council on Law Enforcement Education and Training (CLEET hereinafter), pursuant to 70 O.S. § 3311 and OAC Title 390 Chapter 2, does hereby enter this Final Order of Revocation in the above cause:

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. That Respondent is a certified Peace Officer and a Reserve Officer in the State of Oklahoma.
2. That on or about September 08, 2020, Respondent was charged with one (1) count of aggravated possession of child pornography in violation of 21 O.S. § 1040.12(A) and one (1) count of violation of ok statute via computer in violation of 21 O.S. § 1958 in the District Court of Caddo County case CF-2020-178.
3. That on or about February 24, 2022, Respondent was found Guilty of one (1) count of aggravated possession of child pornography in violation of 21 O.S. § 1040.12(A) and one (1) count of violation of ok statute via computer in violation of 21 O.S. § 1958 and received a fifteen (15) year sentence for count one (1) and a five (5) year sentence for count two (2) in the District Court of Caddo County case CF-2020-178.
4. That pursuant to 70 O.S. § 3311, "The Council shall revoke the certification of any person upon determining that such person has been convicted of a felony or a crime involving moral turpitude or a domestic violence offense or has entered a plea of guilty, or nolo contendere or an "Alford" plea or any plea other than a not guilty plea for a felony offense, a crime of moral turpitude or a crime of domestic violence or is the respondent in a final Victims Protective Order. . ."
5. That pursuant to 70 OS 3311, "The Council shall revoke the certification of any person upon determining that such person has received a deferred sentence for a felony, a crime involving moral turpitude or a domestic violence offense."
6. That Notice of Intent to Revoke was mailed via certified, return-receipt requested, tracking number 7020 0640 0001 4675 8815, on July 6, 2022, to Respondent at his or her address on file with CLEET.

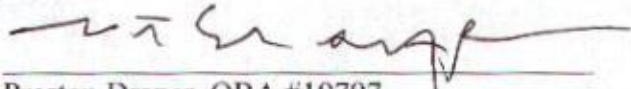
DISPOSITION
